OBJECTIVES

The objective of the product is to provide additional return (with cap) in exchange for the risk of loss of capital.

Underlying

EURO STOXX® UTILITIES Index (ISIN: EU0009658582).

How the return is determined

- **Settlement Amount at Expiry Date:** the amount at the Expiry Date will be determined as follows:
 - **If the Underlying Final Value is higher than or equal to the Barrier Level:** the investor will receive on the Settlement Date an amount equal to 104% of the Issue Price.
 - **If the Underlying Final Value is lower than the Barrier Level:** the investor will receive on the Settlement Date an amount linked to the Underlying Final Value.
- **Plus Amount:** the product provides the unconditional payment of a Plus Amount, which is not linked to the performance of the Underlying. The Plus Amount is equal to EUR 40 and will be paid on the relevant Plus Payment Dates.

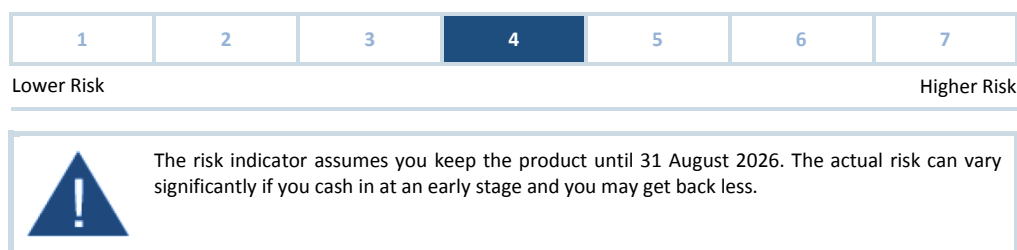
INTENDED RETAIL INVESTOR

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

SUMMARY RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Issuer is not able to pay you. The Issuer has classified this product as 4 out of 7, which is a medium risk class. This classification results from two elements: an estimation of the market risk that rates the potential losses from future performance at a medium level, and an estimation of the credit risk, according to which poor market conditions are unlikely to impact the capacity of the Issuer to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment. If the Issuer is not able to pay you what is owed, you could lose your entire investment.

WHAT ARE THE COSTS?
